ORDINANCE NO. 1619 (2018)**

AN ORDINANCE AMENDING BOND ORDINANCE NO. 1478 (2010) OF THE CITY OF SEA ISLE CITY, COUNTY OF CAPE MAY, STATE OF NEW JERSEY, HERETOFORE ADOPTED ON THE 9th DAY OF MARCH 2010 AND ENTITLED BOND ORDINANCE PROVIDING FOR VARIOUS CAPITAL IMPROVEMENTS APPROPRIATING \$700, 000.00 AND AUTHORIZING THE ISSUANCE OF \$665,000.00 IN BONDS AND NOTES OF THE CITY OF SEA ISLE CITY FOR THE VARIOUS IMPROVEMENTS OR PURPOSES AUTHORIZED TO BE UNDERTAKEN BY THE CITY OF SEA ISLE CITY, NEW JERSEY

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF SEA ISLE CITY, COUNTY OF CAPE MAY, STATE OF NEW JERSEY, (not less than two-thirds of members thereof affirmatively concurring) AS FOLLOWS:

SECTION 1.

Section 3 of Ordinance 1478 (2010) previously adopted by the city of Sea Isle City on March 9, 2010 is amended as follows:
