ORDINANCE NO. 1622 (2018)

AN ORDINANCE TO AMEND THE REVISED
GENERAL ORDINANCES OF THE CITY OF SEA ISLE CITY,
CHAPTER 8-1.3c ENTITLED "SEASONAL PARKING PERMITS" TO INCREASE
THE NUMBER OF SEASONAL PARKING PERMITS FROM THREE HUNDRED
TO FOUR HUNDRED

WHEREAS, The City has a seasonal parking permit program which works in conjunction with metered parking pursuant to Chapter 8-1.3c; and

WHEREAS, there is an exceptionally high demand for seasonal parking permits for 2018 and requests to increase the number of seasonal parking permits; and

WHEREAS, at the request of Council, the administration has reviewed the requests for an increase and recommends the additional number of seasonal parking permits to accommodate the requests from residents and visitors; and

NOW, THEREFORE, BE IT ORDAINED by the Council of the City of Sea Isle City, County of Cape May and State of New Jersey as follows:

SECTION I. Chapter 8 Section 1.3c of the Revised General Ordinances of the City of Sea Isle City, entitled "Seasonal Parking Permits" is hereby amended to delete the following section in its entirety and replace same as follows:

DELETED SECTION:

8-1.3c Seasonal Parking Permits.

c. *Seasonal Parking Permits.* There is established a seasonal parking permit which shall be obtained from the City Clerk at a cost of two hundred (\$200.00) dollars per parking permit. The permit shall be valid from May 15th of the year of purchase through 11:00 p.m. Labor Day of said year. The permit shall permit parking without additional costs at any parking meter or City lot, except as limited in paragraph e. herein.

There shall be three hundred (300) parking permits available per season for purchase. These parking permits shall be sold on a first come first serve basis.

REPLACEMENT SECTION:

8-1.3c Seasonal Parking Permits.

c. *Seasonal Parking Permits.* There is established a seasonal parking permit which shall be obtained from the City Clerk at a cost of two hundred (\$200.00) dollars per parking permit. The permit shall be valid from May 15th of the year of purchase through 11:00 p.m. Labor Day of said year. The permit shall permit parking without additional costs at any parking meter or City lot, except as limited in paragraph e. herein.

There shall be four hundred (400) parking permits available per season for purchase. These parking permits shall be sold on a first come first serve basis.

SECTION II. Severability. If for any reason any section of this Ordinance shall be declared illegal by any Court of competent jurisdiction, the remaining section of the Ordinance shall remain in full force and effect, notwithstanding.

SECTION III. Repealer. Any Ordinance or provision thereof inconsistent with this Ordinance is hereby repealed to the extent of such inconsistency.

SECTION IV. Publication. This Ordinance shall take effect immediately upon the adoption and publication in accordance with the law.
