ORDINANCE NO. 1607 (2017)

**AN ORDINANCE TO AMEND CHAPTER 2 ENTITLED “ADMINISTRATION” OF
THE REVISED GENERAL ORDINANCES OF THE CITY OF SEA ISLE CITY
CHANGING NUMBERING OF CHAPTER 2 SECTION 9 TO ACCOMMODATE NEW
EMS DIVISION.**

WHEREAS, the City of Sea Isle City will adopt an Ordinance to create an Emergency Medical Service Division within Chapter 2 Section 9; and

WHEREAS, the City is in need of renumbering Chapter 2 Section 9 to accommodate the added section creating the Division; and

NOW, THEREFORE, BE IT ORDAINED by the Council of the City of Sea Isle City, County of Cape May and State of New Jersey as follows:

SECTION I. Chapter 2 Section 9 of the Revised General Ordinances of the City of Sea Isle City, entitled “DEPARTMENT OF POLICE” is hereby amended to renumber the followings sections as follows:

SECTION IV. Publication. This Ordinance shall take effect immediately upon the adoption and publication in accordance with the law.
