## **ORDINANCE NO. 1614 (2017)**

AN ORDINANCE TO AMEND THE REVISED GENERAL ORDINANCES OF THE CITY OF SEA ISLE CITY VARIOUS SECTIONS AND SCHEDULES IN CHAPTERS 7 ENTITLED "TRAFFIC" TO REFLECT NECESSARY CHANGES TO ALLOW FOR CONSISTENCY AND TRAFFIC FLOW.

**WHEREAS**, the City of Sea Isle City continues to review and update its traffic ordinances; and

**WHEREAS**, the Council seeks to address handicap parking, one way streets, and 15 minute parking in certain areas due to changes within the City; and

**NOW, THEREFORE, BE IT ORDAINED** by the Council of the City of Sea Isle City, County of Cape May and State of New Jersey as follows:

**SECTION I.** Chapter 7 Section 7.5 of the Revised General Ordinances of the City of Sea Isle City, entitled "Parking Time Limited on Certain Streets" is hereby amended to delete 15 minute parking space as follows and add 15 minute parking spaces (all other designated streets and spaces in Ordinance remain as is) as follows:

**SECTION VII.** Severability. If for any reason any section of this Ordinance shall be declared illegal by any Court of competent jurisdiction, the remaining section of the Ordinance shall remain in full force and effect, notwithstanding.

**SECTION IX.** Repealer. Any Ordinance or provision thereof inconsistent with this Ordinance is hereby repealed to the extent of such inconsistency.

**SECTION X.** Publication. This Ordinance shall take effect immediately upon the adoption and publication in accordance with the law.
