ORDINANCE NO. 1620 (2018)**

AN ORDINANCE AMENDING BOND ORDINANCE NO. 1566 (2014) OF THE CITY OF SEA ISLE CITY, COUNTY OF CAPE MAY, STATE OF NEW JERSEY, HERETOFORE ADOPTED ON THE 8th DAY OF APRIL 2014 AND ENTITLED BOND ORDINANCE FOR IMPROVEMENTS TO THE WATER/SEWER UTILITY APPROPRIATING \$2,900, 000.00 AND AUTHORIZING THE ISSUANCE OF \$2,900,000.00 IN BONDS AND NOTES OF THE CITY OF SEA ISLE CITY FOR THE VARIOUS IMPROVEMENTS OR PURPOSES AUTHORIZED TO BE UNDERTAKEN BY THE CITY OF SEA ISLE CITY, NEW JERSEY

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF SEA ISLE CITY, COUNTY OF CAPE MAY, STATE OF NEW JERSEY, (not less than two-thirds of members thereof affirmatively concurring) AS FOLLOWS:

SECTION 1.

Section 3 of Ordinance 1566 (2014) previously adopted by the city of Sea Isle City on April 8, 2014 is amended as follows:

SECTION 2

The Capital budget of the City of City of Sea Isle City is hereby amended to conform to the provisions of this ordinance to the extent of any inconsistencies created thereby.

SECTION 3.

This Bond Ordinance shall take effect twenty (20) days after first publication thereof after final adoption, as provided by said Local Bond Law.
