**ORDINANCE NO. 1621 (2018)**

**AN ORDINANCE TO AMEND THE REVISED GENERAL ORDINANCES OF THE CITY OF SEA ISLE CITY CHAPTER 7 ENTITLED “TRAFFIC” TO MAKE 40TH STREET, 51ST STREET, AND 52ND STREET TWO WAY STREETS FROM LANDIS AVENUE TO CENTRAL AVENUE.**

**WHEREAS**, the City of Sea Isle City continues to review and update its traffic ordinances; and

**WHEREAS**, the Council seeks to address one way streets in certain areas due to changes within the City; and

**NOW, THEREFORE, BE IT ORDAINED** by the Council of the City of Sea Isle City, County of Cape May and State of New Jersey as follows:

**SECTION II.** Chapter 7 Section 9 of the Revised General Ordinances of the City of Sea Isle City, entitled “ONE-WAY STREETS” is hereby amended to delete the following streets in their entirety as follows:

**7-9 ONE-WAY STREETS.**

<i>Name of Street</i>	<i>Limits</i>	<i>Direction</i>
40 <sup>th</sup> Street	Central Avenue to Cini Avenue	Westbound
51 <sup>st</sup> Street	Central Avenue to Landis Avenue	Eastbound
52 <sup>nd</sup> Street	Landis Avenue to Central Avenue	Westbound

**SECTION II.** Severability. If for any reason any section of this Ordinance shall be declared illegal by any Court of competent jurisdiction, the remaining section of the Ordinance shall remain in full force and effect, notwithstanding.

**SECTION III.** Repealer. Any Ordinance or provision thereof inconsistent with this Ordinance is hereby repealed to the extent of such inconsistency.

**SECTION IV.** Publication. This Ordinance shall take effect immediately upon the adoption and publication in accordance with the law.
