**2017-2018 KAYAK RENTALS ON PUBLIC BEACHES AREA 1, 2 & 3**

NOTICE is hereby given that sealed bids will be received by the City of Sea Isle City, New Jersey for the 2017-2018 Franchise of Kayak Rentals on Public Beaches Areas 1, 2 & 3 Bid III. The bids are to be received sealed and must be addressed to the City Clerk, City of Sea Isle City, Sea Isle City Hall, 233 JFK Blvd., Sea Isle City, NJ 08243 and will be opened and read in public at that same address on

**TUESDAY, MARCH 21, 2017 AT 2:00 PM PREVAILING TIME**

and will be opened thereafter and read publicly, for Kayak Rentals on Public Beaches along the ocean front in Sea Isle City, New Jersey. There are (3) three designated areas that have been established by City Resolution for kayak beaches. Bid areas #1, #2 & #3 shall have a **minimum** bid of \$1,500.00 each for the summer season 2017 and again Bid areas #1, #2 & #3 shall have a **minimum** bid of \$1,500.00 each for the summer season 2018. Each bidder agrees to make available for rental to the general public kayaks in Bid Areas #1, #2 & #3.

The successful bidder shall not sublet or transfer any phase of their beach concession area without written permission from City Council. All successful bidders will also be responsible for maintaining the safe guard of all equipment that will be used and left unattended during the length of the contract season 2017 and 2018.

The awarded vendor(s) shall not sublet or transfer any phase of their beach concession area without written permission from City Council. Vendor(s) are also required to meet with the Director of Public Works for the placement and the size of a storage unit (if a storage unit deems necessary). All awarded vendor(s) will also be responsible for maintaining the safeguard of all equipment that will be used and left unattended during the length of the contract seasons 2017 & 2018.

Bidder shall be responsible for compliance with "The Prevailing Wage Act", C. 150, PL 1973 (N.J.S.A. 34:11-56.25) and C. 127, PL 1975, Supplement to Law Against Discrimination (Affirmative Action) and for compliance with provisions of C. 33 PL 1977, which requires that no corporation or partnership shall be awarded any municipal contract for the performance of any work or the furnishing of any materials and supplies, unless prior to the receipt of the bid or accompanying the bid of said corporation or partnership there is submitted a statement setting forth the names and addresses of all stockholders in the corporation or partnership who own ten percent or more of its stock of any class, or all individual partners in the partnership who own a ten percent or greater interest therein.

Bids may be sent or hand delivered by the bidder or his agent to the City Clerk, City Hall, City of Sea Isle City, 233 JFK Blvd., Sea Isle City, N.J., 08243 up to 3:30 p.m., on Monday, March 20, 2017 or delivered at 2:00 a.m. to the City Clerk, City Hall, City of Sea Isle City, 233 JFK Blvd., Sea Isle City, N.J. on Tuesday, March 21, 2017. Bids will not be received or accepted later than the time designated aforesaid for their receipt.

Contract award shall be determined by the **grand total for the designated areas two (2) year bid price**. It is the intent of the City of Sea Isle to award to only **(1) vendor per area** for the duration of the two year contract.

All bids must be accompanied by a certified check or cash for not less than 10% of the bid price, balance to be paid no later than June 30, 2017 and the following year May 1<sup>st</sup> 2018 of the acceptance of bid by the City. The successful bidder shall be required to post with the City Clerk of the City of Sea Isle City evidence of a public liability insurance policy including personal injury and property damage coverage's with the coverage's to be no less than \$1,000,000.00 for commended Single limits for bodily injury and property damage. The successful vendor(s) shall provide a hold harmless agreement in favor of the City of Sea Isle City.

Bids must be enclosed in the sealed envelope supplied bearing the name and address of the bidder. Bids must be marked "KAYAKS" and shall also designate each Beach Area for which their bid is intended. Each designated area is to be bid separately and addressed to the City Clerk, Sea Isle City Hall, City of Sea Isle City, 233 JFK Blvd., Sea Isle City, NJ 08243. A description of each designated bid area is available from the City Clerk's Office, City Hall, City of Sea Isle City, 233 JFK Blvd., Sea Isle City, NJ 08243.

Each bidder shall comply with the "Law Against Discrimination", P.L. 1975 Chapter 127, as amended.

Council of the City of Sea Isle City reserves the right to reject any or all bids that are not responsive to the specifications and reserves the right to waive any informalities in a bid and any accompanying documents, in accordance with State Statues 40A:11-13.2.
