ORDINANCE NO. 1722 (2025)

AN ORDINANCE TO AMEND THE REVISED
GENERAL ORDINANCES OF THE CITY OF SEA ISLE CITY
CHAPTER 20 TO UPDATE MARINA BOAT SLIP FEES

WHEREAS, the Council of the City of Sea Isle City, continues to review and update its ordinances; and

WHEREAS, the City Council has an interest to update fees in ensuring that the Marina boat slips be appropriately developed, maintained, and managed with the least expenditure of public funds and that the boat slips be utilized by the public to the maximum extent possible.

WHEREAS, the City has found this ordinance to be in the best interest of the health, safety, and welfare of the citizens and visitors of the City; and

NOW, THEREFORE, BE IT ORDAINED by the Council of the City of Sea Isle City, County of Cape May and State of New Jersey as follows:

SECTION I. Chapter 20 Section 3.4 of the Revised General Ordinances of the City of Sea Isle City, entitled “Fees” is hereby amended to delete the following section in its entirety and replace same as follows:

20-3.4 Fees.

- a. Slips numbered 1 through 19 are not in existence, and the following are designated: #94 emergency boat, #T6 Coast Guard Emergency. Fees for all other boat slips in the marina at 42nd Street starting with Slip Number 20 shall be as designated herein as of January 1 of each year:

Slips	Fee
Slip Nos. 20-42, 18 feet	\$1,943
Slip Nos. 43-62, 20 feet	\$2,134
Slip Nos. 63 and 64*, 40 feet	\$4,037
Slip Nos. 65-71*, 30 feet	\$3,091
Slip Nos. 72-102	\$2,624
Slip Nos. T1-T6	\$1,943

Notes:

* Includes water and electricity and one parking permit per boat slip to be issued at time of payment in full of boat slip. This parking permit for the boat slip shall be used in designated spots only. Designated spots shall be parking spots numbered 2-48, 49-92, and 341-393 only (along the Baywalk). No other parking spaces may be utilized by the parking permit included with the boat slip.

- b. Fees for the boat ramp shall be:

1. Day pass: \$15 .
2. Seasonal pass: \$125 .
3. Commercial seasonal pass: \$250.

- c. Each renter must sign a contract with the City for each season. 50% of the contract price is due at the time the contract is signed. The remaining 50% of the contract price is due on April 1. The fees indicated herein shall be effective 2025 and remain in effect until modified.

SECTION II. Severability. If for any reason any section of this Ordinance shall be declared illegal by any Court of competent jurisdiction, the remaining section of the Ordinance shall remain in full force and effect, notwithstanding.

SECTION III. Repealer. Any Ordinance or provision thereof inconsistent with this Ordinance is hereby repealed to the extent of such inconsistency.

SECTION IV. Publication. This Ordinance shall take effect immediately upon the adoption and publication in accordance with the law.

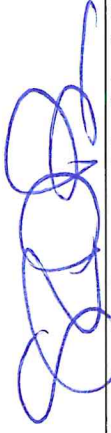
